4. FIRST AID MEASURES

5. FIREFIGHTING MEASURES

Hazardous combustion products: During a fire, smoke may contain the original material in addition to combustion products of varying composition which may be toxic and/or irritating. Combustion products may include and are not limited to: Carbon monoxide. Carbon dioxide.

Unusual Fire and Explosion Hazards: Do not permit dust to accumulate. When suspended in air dust can pose an explosion hazard. Minimize ignition sources. Advice for firefighters

7. HANDLING AND STORAGE

Exposure controls
